BYLAW 1295, 2025

A BYLAW TO AMEND ZONING BYLAW 561, 2007

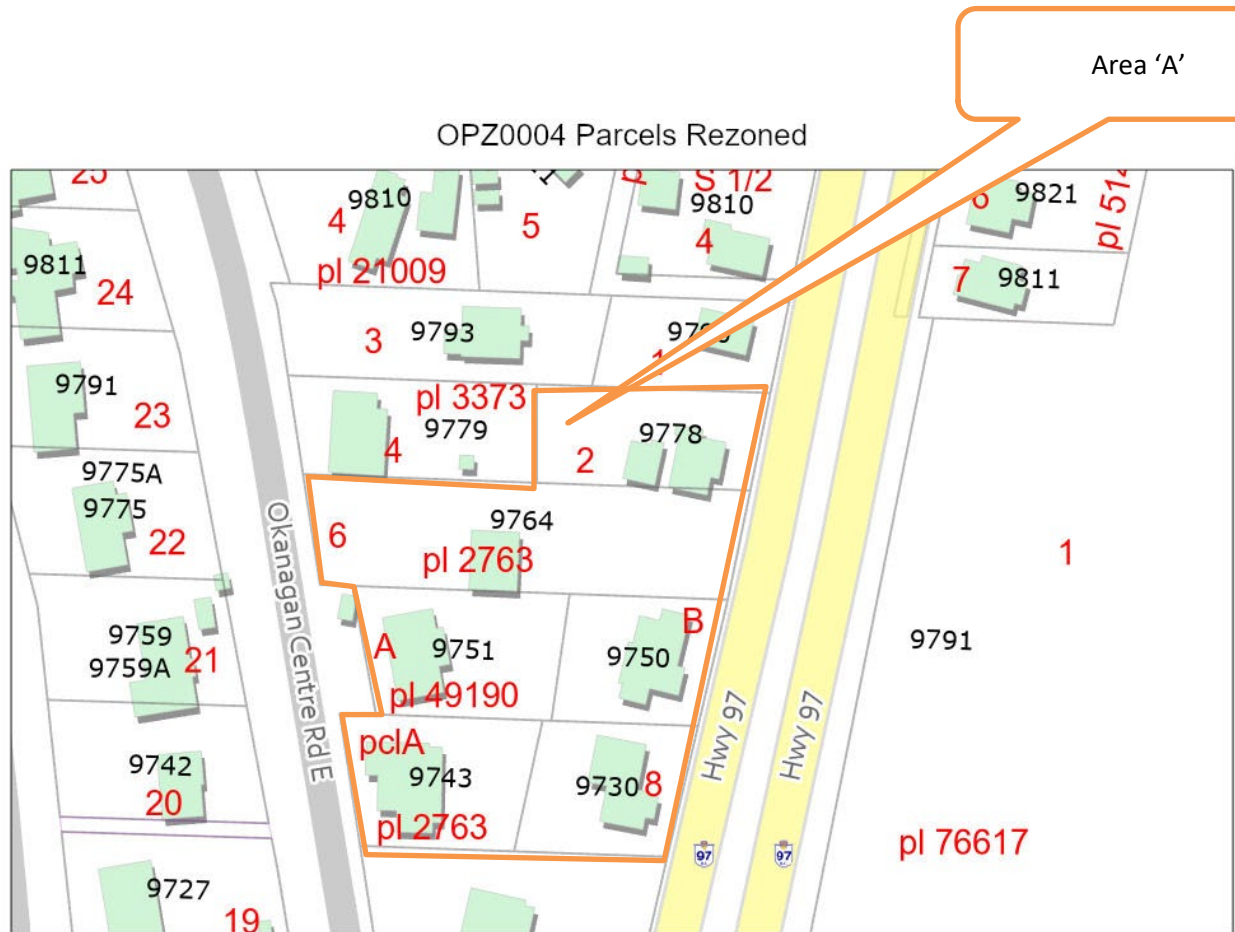

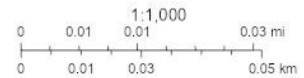
