# **EXECUTIVE SUMMARY**

Over the last decade the district has been working on updating and revising the Liquid Waste Management Plan. In 2021 the formal Environmental Assessment process, was kicked off. Part of the application included demonstrating how the District consulted with the community on the issues and possible solutions, along with cost.

The project team made the decision to solicit engagement from the community using education, humor and playfulness, because of the topic, while conveying a sense of urgency on the issue. Applying for the UBCM award recognizes the creativity, planning and execution of the community education and engagement component of the LWMP application. Educating the community on issues, a growing district faces, in a way that is understandable and easy to absorb - was no easy task. However, the project team enthusiastically met the challenge and was successful. The application will recognize the efforts of Council, the project team, advisory group along with the many who took the time to understand the issues and effectively collaborated to identify suitable long-term solutions for the community.
