DESCRIPTION:	A Bylaw to close road and sell the parcel created to the adjacent property owner

QUESTION

Does Council support adoption of the Bylaw to close the section of Whiskey Cove Road and sell the parcel created by the closure to the adjacent property owner?

OPTIONS

- A. THAT Road Closure Bylaw (15892 Carr's Landing Road) 1194, 2023B be adopted.
- B. THAT Road Closure Bylaw (15892 Carr's Landing Road) 1194, 2023 be deferred pending additional information from Council.
- C. THAT first, second and third reading of Road Closure Bylaw (15892 Carr's Landing Road) 1194, 2023 be rescinded and the file be closed.

EXECUTIVE SUMMARY

Council gave Road Closure Bylaw (15892 Carr's Landing Road) 1194, 2023 three readings on January 17, 2023. Council is required to hear from the members of the public who wish to speak to the Bylaw attached hereto as Attachment A.

KEY INFORMATION

The owners of 15892 Carr's Landing Road approached the District proposing to purchase a portion of Whiskey Cove Road adjacent to their property. Staff determined the road is not required for future development or for District purposes. A legal survey was performed and the Owners offered \$250,000 for the purchase of the closed road. Should Council adopt the bylaw, staff will prepare a Contract of Purchase and Sale with the adjacent property owners, Martin and Catherine Burnley. The contract requires the purchaser to amalgamate the closed road with their existing parcel located at 15892 Carr's Landing Road.

CONSULTATION AND COMMUNICATION

Advertisements were placed in the Lake Country Calendar on February 9, 2023, February 16, and February 23, 2023 outlining the terms of the sale in accordance with Section 26 of the Community Charter, attached hereto as Attachment B.
