# **EXECUTIVE SUMMARY**

Beginning in 2021 staff has been collaborating with the Economic Development & Tourism committee to scope and eventually shape the proposed Economic Development & Tourism Strategy. The strategy has evolved over the past two years into a document that is achievable within a limited budget and one part-time staff member to facilitate and implement the plan.

#### **KEY INFORMATION**

Development of the Economic Development & Tourism strategy is a **Council Strategic Priority** that includes:

- Support Opportunities to Diversify Lake Country's Tax Base.
- Implement the Agricultural Plan.
- Encourage Growth of the Downtown Core.

Throughout the strategy Council's priorities are addressed by way of tactics. Several of the tactics have already started and will continue until completion. Targets and goals have been established to align with the following plans:

- Official Community Plan
- Mobility Master Plan
- Agriculture Plan

### **DESIRED BENEFIT**

- Support Opportunities to Diversify Lake Country's Tax Base by supporting and assisting with the Lake Country Business Park.
- Support Implementation of the Agricultural Plan.
- Encourage Growth of the Downtown Core and connection of Main Street to the Woodsdale neighbourhood through grant funding.

#### STRATEGIC RELEVANCE AND COMMUNITY SUSTAINABILITY

Environmental programs have been identified and meant to enhance the quality of life for those working and living in the community while assisting businesses to further their commitments and targets towards environmental stewardship.

# **UNINTENDED OUTCOMES**

Tactics within the strategy not implemented by 2027 or Council makes the decision that the Economic Development & Tourism is no longer a strategic priority.

#### **IMPACT ON STAFF CAPACITY AND FINANCIAL RESOURCES**

Tactics that require funding will either come from grants that Council supports applying for in the future or through future budget requests. Implementation of the strategy will be facilitated by the Economic Development Specialist.

# **COMMENTS FROM EXTERNAL AGENCIES, COMMITTEES AND STAKEHOLDERS**

Economic Development & Tourism Committee assisted with crafting the strategy. Through discussions the committee has endorsed and will continue to support the strategy over the next five-years.

#### **CONSULTATION AND COMMUNICATION**

If Council approves the strategy, it will be made published and easy to access through lakecountry.bc.ca. The Economic Development & Tourism Committee will have a standing agenda item recommending that the committee reviews the strategy to evaluate progress and determine where support is required and if modifications are required to achieve success.
