She is extremely grateful for the fire response over the long weekend in Carr's Landing and was impressed by how fast 9 lightening strikes were put out by the dedicated firefighters who responded. Lastly, Councillor Reed noted September 11, 2024 is the next Carr's Landing Local Service Area (LSA) meeting at the Creekside Theatre at 6:30 p.m. She encouraged the community to attend.
