SUBJECT: 2022 EARLY APPROVAL OF CAPITAL AND STAFF REQUESTS

#### **KEY ISSUE AND ESSENTIAL QUESTION:**

To request that Council provide approval to expend funds for specific capital projects and staff positions prior to the adoption of the 2022-2026 Financial Plan. Does advancing projects prior to the adoption of plan provide benefit to the organization and the community?

#### **OPTIONS:**

A. THAT the following Capital Projects and new staff position be given early approval to allow expenditure prior to adoption of the 2022-2026 Financial Plan:

- C. THAT no expenditures for Capital Projects or new staff positions be approved prior to the adoption of the 2022-2026 Financial Plan.

#### **EXECUTIVE SUMMARY:**

#### **Key Information:**

Some projects require early approval to achieve competitive pricing, meet operational needs or align with other projects.

Some staff positions can be filled earlier than the adoption to address challenges being faced or to coincide with projects being undertaken. The staff positions being presented for early approval are all funded through sources other than taxation.

All items with reasoning as to why early approval is requested is contained in Schedule A.

#### **Relevant Observations:**

Each year as the list of capital projects is considered, the timing of those projects is also considered. Some projects require early tendering to maximize the number of potential submissions and most competitive bids. Some purchases require extensive lead time to the receive the items such as Fire equipment and apparatus. Early approval for staffing positions funded through sources other than taxation allows Human Resources to start the recruiting process earlier and maximize the chance of hiring the best possible candidate rather than hiring all positions at once and in a short window after adoption of the financial plan.

#### **Strategic Questions:**

What are the efficiencies or values for the District that are obtained from approving individual items prior to adoption of the financial plan?

#### **Strategic Relevance & Community Sustainability:**

The community can achieve better value for money if some items are purchased or tendered earlier in the fiscal year.

#### **Key Result:**

That the best efficiency and value is obtained in the purchase of capital projects and equipment and operation efficiencies are created.

#### **Desired Benefit of Key Result:**

To maintain and improve operational efficiency and ensure the best value for taxpayer money is achieved.

#### Requisites:

All items have passed first reading of the Financial Plan bylaw.

#### **Unintended Outcomes:**

No unintended outcomes.

#### **BACKGROUND/HISTORY**

#### **DISCUSSION/ANALYSIS**

#### **Legislation & Applicable Policies**

Under section 173 of the *Community Charter*, a municipality can only make expenditures that are included in its financial plan. Annually, requests are made to Council to ask to expend certain capital and salaries for new positions prior to the adoption of the plan. Existing operations may continue without approval as those expenditures were approved with the prior 5-year financial plan in 2021.

#### **Technical Considerations:**

- Impact on Infrastructure and Other Municipal Services
  Early approval of some capital allows for opportunities for better pricing or timing to align with other projects.
- Impact on Staff Capacity and Financial Resources (Cost/Benefit Analysis)
  All projects have an impact on staff capacity and by approving some projects early, the workload can be better spread over the year. Approving the positions funded through sources other than taxation early assists in removing a bottleneck for Human Resources and helps ensure we hire the best possible candidates.
