#### STRATEGY SESSION OBJECTIVE

Receive feedback from Council on the draft Terms of Reference and draft Engagement Plan for the Official Community Plan update program.

#### **EXECUTIVE SUMMARY**

The District has begun the process to review and update the Official Community Plan (OCP). The project is in its first phase, Background and Visioning.

The purpose of this report and strategy session is to provide Council with an opportunity to review two key process documents: the draft Terms of Reference (TOR) for the OCP review and update (Attachment A), and the draft Engagement Plan (Attachment B).

The report includes additional general project updates on the process for Council's information.

#### BACKGROUND

At Council's strategy session on March 4, 2025, staff introduced the workplan (Attachment C) for the OCP review and update. Background work on the project has begun and the updated OCP is anticipated to be ready for Council's consideration of formal adoption in July 2026.

As noted in the previous strategy session, Council will act as the Steering Committee for the OCP review and update. Council will be provided with regular process updates and results at key milestones, and opportunities to provide feedback and direction on the OCP update and review.

Council provided feedback to staff on the draft workplan, including the guiding principles for the OCP review and update, and the measures of success. This report and associated strategy session is an opportunity for Council to review the new and updated information.

#### DISCUSSION/ANALYSIS

## Terms of Reference

Staff have developed a terms of reference (TOR) for the proposed OCP review and update (Attachment A). The draft TOR is based on the information presented to Council in the strategy session on March 4<sup>th</sup>, and on feedback received from Council during the associated discussion. The TOR outlines the:

- purpose, goals and objectives of the review,
- guiding principles,
- project background,
- overall process and timeline,

- public engagement plan, and
- administrative information and resources.

The TOR provides a general overview of the OCP review and update process, and would be used to guide the District's future project work.

## **Guiding Principles**

Based on Council feedback from March 4<sup>th</sup>, the guiding principles have been updated to highlight community engagement and strategic policy development. The updated principles are included below:

- Generate strong community engagement in the OCP review process.
- Develop a clear and coordinated vision to guide community development in the District over the next 25 years.
- Build on successful policies in the existing OCP and other strategic documents.
- Update, modify, or remove policies inconsistent with the community vision, where appropriate.
- Incorporate themes of Council's 2025 Strategic Plan and other District priorities.

The TOR and the guiding principles both highlight the intention to develop a strong public engagement plan that generates community interest, encourages participation, and supports the development of a document that the public can support and understand.

## Engagement Plan

The District has developed an engagement plan for the OCP review and update (Attachment B). The draft engagement plan includes the following purpose statement:

An engagement plan provides a structured approach to involving the community and stakeholders in meaningful and effective ways. It outlines how, when, and why engagement will occur, ensuring that the process is transparent, inclusive, and aligned with project goals.

As noted during Council's discussion of the OCP workplan on March 4<sup>th</sup>, engagement and communication will be key to developing a planning document that is informed by strong public participation and developed to be clear and meaningful.

The engagement plan was drafted with support from a planning consultant. The draft plan follows the structure of the workplan for the OCP review and update. The engagement plan includes the following information:

- goals, objectives, and indicators of success,
- project timeline,
- summary and detailed engagement activities,
- identified stakeholders,
- key issues, risks, and mitigation strategies, and
- plan for communications.

The public engagement plan will drive the development of each phase of the workplan to review and update the OCP, and to meet the overall goals and objectives of the project.

## Measuring Project Success

In addition to overall project guidance included in the TOR, the engagement plan includes goals, objectives, and potential indicators to evaluate the success of the program. The project team will monitor the results of public engagement throughout the process. Each future phase of the project will be informed by the cumulative results

from completed phases of engagement with the goal of continuous improvement. Council will be provided with summaries of engagement activities throughout the OCP review and update.

## General Process Updates

Staff are completing background work to prepare for future OCP development phases and engagement activities. The following summary provides additional information:
